LDC Finance Treasurer's CT Area Fall Assembly Report

November 7, 2020

Good afternoon, everyone!

I wish to welcome all the new GRs to the Fall Assembly. I also wish to welcome our new Finance Committee members: Pat S., who joined in July and Ann B., Past Delegate Panel 54, who joined in October.

The LDC account balance on September 30, 2020, the end of 3rd Quarter, is \$13,146.20. See Chart.

It is no surprise that the current world pandemic has dramatically altered the financial activity at our Literature Distribution Center. LDC literature sales are severely diminished. The LDC Office has been able to cut costs to meet the dramatic decline in literature sales. Our gross income by quarters dropped an average of 62.1% in comparison to 2019 and our expenditures for the same quarters were cut back for an average quarterly decrease of 58.9%. Our current Net Income/Loss for the year to date is minus \$902.

Our LDC as well as online groups on line have found new ways to provide our membership, especially our newcomers, with Conference Approved Literature. Tradition 5, our "one purpose: to help families of alcoholics", guides our actions to make our literature available to members and newcomers in our meetings. To that end the LDC is open for both regular mail orders from groups and individual members. We also provide curbside pickup on Tuesdays during LDC Office hours for members near Hartford. The LDC literature order form is on our CT website for download. World Service also provides many free downloads, especially in the section for newcomers. On line meetings are challenged to find creative ways for members and newcomers to access a group's stock of literature.

The Finance Committee and I wish to thank the many individuals and groups who have so generously send contributions to the LDC over and above your regular group's expenses. Contributions YTD stand at \$1401, amazingly only 9% less than 2019. Thank you so very much for your generosity.

The LDC does not accept any money from any outside enterprises, corporations or individuals. Even corporate matching funds from your place of work to Al-Anon cannot be and is not accepted (Trad.7).
